
The Nifty faced a flat expiry in November, ending down 0.14%. It has been consolidating in a broad range with support at 25300 and immediate hurdle at 26200. The index is close to its all-time high and is likely to surpass the same in the coming series, if manages to hold 25700 on the downside. The Bank nifty index has been the outperformer and ended the November series with positive returns of 0.50%.

The Nifty saw an 68.77% rollover in the next series, far lower than the three-month average of 80%, indicating lack of momentum at the start of the series. The index remains in a 'buy on dips' mode if it can hold the support of 25700 in the short term. The Bank nifty index witnessed rollover of 70.44% which is again far lower than the three-month average indicating sideways action at the start of the series.

# Nifty OI Concentration (In lots) (Monthly Expiry)




Highest open interest build-up (Monthly OI)

# Bank Nifty OI Concentration (In lots) (Monthly Expiry)




